



Sea la vie Summer Event Sweepstakes Rules

1. Eligibility: Sweepstakes (the “Sweepstakes”) is open only to those who register in person at a Traton Homes sales office, or otherwise submit an entry in accordance with these rules, and who are 21 years old as of the date of entry.
